(U) Identification of Buzzer System used by Brooklyn, NY Gang Members to Deter Law Enforcement Disruption.

(U//LES) According to FBI source reporting, a recently identified neighborhood-based street gang, operating in the Ft. Greene Section of Brooklyn, New York, has installed a buzzer system in their apartment complex to facilitate their narcotic and weapon sales operation. (Source Comment: This method is being used to prevent being robbed by rival drug-dealers, as well as, to deter law enforcement disruption).

(U//LES) The crew has installed two buzzers in the apartment building where their illicit distribution network is operating. One buzzer is inside of the 4th floor room where they are stashing the drugs and weapons and another is at the end of the hall on the 4th floor, near the staircase leading to the 3rd floor.

(U//LES) A customer will hit the buzzer when they arrive on the 4th floor to alert the gang members inside of the stash room that a sale is being requested. After hitting the buzzer, the customer will then walk down to the third floor and one of the individuals inside the stash room will come out to verify that the hallway is clear to make the sale. After verifying that the hallway is clear, the gang member will proceed to meet the customer on the third floor and
